GALLOWAY SAFEGUARDING STATEMENT

OCTOBER 2024

Continuing the good practice of previous years, the Safeguarding Community in Galloway Diocese embraces the Safeguarding Standards outlined within *'In God's Image'*. Our group of volunteers in ministries across the Diocese continue to be safely recruited and trained, and these volunteers work in our parishes, schools, and communities, promoting a culture of safeguarding. We are grateful to them.

Through the continued dedication of the volunteer and training network, the Diocese provides safer recruitment for all those who engage in specific ministries, for example as Eucharistic Ministers taking Holy Communion to the sick and housebound, or as members of the St Vincent De Paul Society or the Legion of Mary.

We are in the process of finalising our Diocesan Action Plan that is born out of this year's Annual Audit, which was independently undertaken by the Scottish Catholic Safeguarding Standards Agency (SCSSA). The findings and recommendations of the Audit are being reviewed and implemented by the Diocesan Risk Assessment Management Team (DRAMT), the Diocesan Safeguarding Advisory Group (DSAG) and the Safeguarding Operational Core Team (SOCT).

The Scottish Catholic Safeguarding Standards Agency (SCSSA) continue to work with the Archdioceses and Dioceses in Scotland in the key core activities of Survivor Engagement, Education and Training, Safeguarding and Audit, Finance and Remuneration and Policy and Resources.

In the Diocese of Galloway, an appeal was made for new volunteers to join the numbers of experienced Parish Safeguarding Coordinators (PSC's). As with previous appeals, this call was answered with generosity, and we have now strengthened our PSC numbers in the Parishes.

This year we had a Training and Development Day for Parish Safeguarding Coordinators and Diocesan Safeguarding Advisors, held on 05 October 2024. This was a welcome opportunity for volunteers in the Safeguarding Community to come together and learn about how Safeguarding is being managed and developed in each of our Parishes.
